- Appraisal Services provided by Cochrane and Associates. The contract is a "shall no exceed". September is the month of
  most activity expenses are yet to be entered.
- Mapping and GIS this is the geographical information system used by the town that maps out all of the tax plots and items
  of interest. Maintenance fees are going up this year.
- · Software Expenses maintenance for the Appraisal and Finance software

### Technology

- Technical Services -Provided by Mainstay Technology at a rate of \$78/user/month for 61 users. They also watch over servers
  and network infrastructure. It seems that users are satisfied with the level of support they receive.
- · Software Expenses maintenance for other software
- · Computer Supplies Acts as Central Purchasing for all departments (consumables)
- Special Projects All Windows 2003 servers (outdated, out of warranty, no longer supported by Microsoft) are being replaced with Windows 2012 servers. These are on-premise systems. The email server, however, is being outsourced to the Cloud to Microsoft Office 365 at a cost of \$4/user/month. Wireless access points are being upgraded as well as the router types being consolidated.
